
Survey demographics

A combined 365 community members responded to a survey regarding alcohol, tobacco, e-cigs and vaping, marijuana and marijuana products, and other drug use among youths aged 9-18 years in the community.

The Collaborative survey: 168 respondents; ACT Bennington survey: 197 respondents

A majority of respondents were 25-65 years of age




Dependent children

Youth substance use in the community




Prevention and reduction of youth substance use is an important issue for our community.¹

Our community is committed to preventing and reducing youth substance use.




In our community, how much of a problem is youth substance use?²



I believe that youth are valued in this community.³




I believe I play an active role in preventing youth substance

I would support town policies that would limit youth exposure to:



As long as they are in their home, it is acceptable for parents and other adults to offer underage youth:




Open-ended comments: offering alcohol &

Appendix: Exact question wording

Some survey questions were worded differently between the Collaborative and ACT Bennington surveys. It is possible that these differences explain some of the variation in response between the two surveys. Exact wording is provided below for comparison.

Page 2:

- 1. The Collaborative: Prevention and reduction of youth substance use is an important issue for our community.
 - ACT Bennington: Prevention and reduction of youth substance (alcohol, tobacco, marijuana, and other drugs) use is an important issue for our community.
- 2. The Collaborative: In our community, how much of a problem is youth substance use? ACT Bennington: In our community, how much of a problem is youth use of substances such as alcohol, tobacco, and other drugs?
- 3. The Collaborative: I believe youth are valued in this community.

 ACT Bennington: Do you feel that youth are valued in the community?
- 4. The Collaborative: I believe that I play an active role in preventing youth substance use. ACT Bennington: I believe I play an active role in prevention (i.e., by communicating with my youth, supporting prevention organizations, etc.)
